- I. Administrative
 - a. Campus
 1. Legislative uncertainty in appropriation bills; will require reconciliation when they reconvene – concerns with inflation adjustment allocation.
 2. Library has extended its hours; open until 1:00 a.m. Sunday through Thursday; added Saturday hours; do we want to participate in Dead Week snacks again this year? – one night at 9:00 p.m. during dead week – Dr. Murray will contact Library Staff – Holly and Mimi volunteered to help.
 3. Dean Grimes presented the downtown project at the Gorilla Gathering in Wichita last Thursday and will do so again tonight in Joplin. Turnout at Wichita was very good – 75 people. Good feedback on Gorilla Rising.
 4. VP Ball chairing Tuition Committee meetings to consider this year's position and request. Deans are on committee this year. First adjustment in at least two or three years.
 - b. College
 1. Gorilla Rising; Colonial Fox Theater Foundation walk-through last Wednesday with architects and administrators; *much* work still needed on functional/aesthetic spaces.
 2. Internship Coordinator Search; update (Lynn and Holly) – position is posted, first consideration is 04/26
 3. Review revised Kelce Organizational Chart; reflects changes over past year – reviewed chart and suggested changes; Dr. Grimes will revise and present again.
 4. Faculty Personnel; Provost Smith granted permission to search for Dr. Horner's position to be vacated at end of next academic year; Need to evaluate other needs relative to potential pool of available funds to divide up and create hiring strategy going forward
 5. 25th Anniversary of AACSB Accreditation; consider web banner designs – previewed proposed banners – Dean Grimes will work with Kylie; no consensus on which design is best, but many liked the plaid.
 6. Sabbatical Showcase; tomorrow at 10:00 a.m. in the CTLT – Linden Dalecki will present

 - a. International Business Program; Dean Grimes discussed with Provost Smith; need to work through College Curriculum Committee and then present plan to faculty for a vote – discussion. Dr. Binder will contact Dr. Goedeke about going forward with proposal to phase out IB major with Kelce Curriculum/AOL Committee and faculty senate. Plan to implement IB concentration under econ; will attract international students because of STEM emphasis which should make program attractive.

 - c. Data Analytics task force met yesterday to craft a proposal

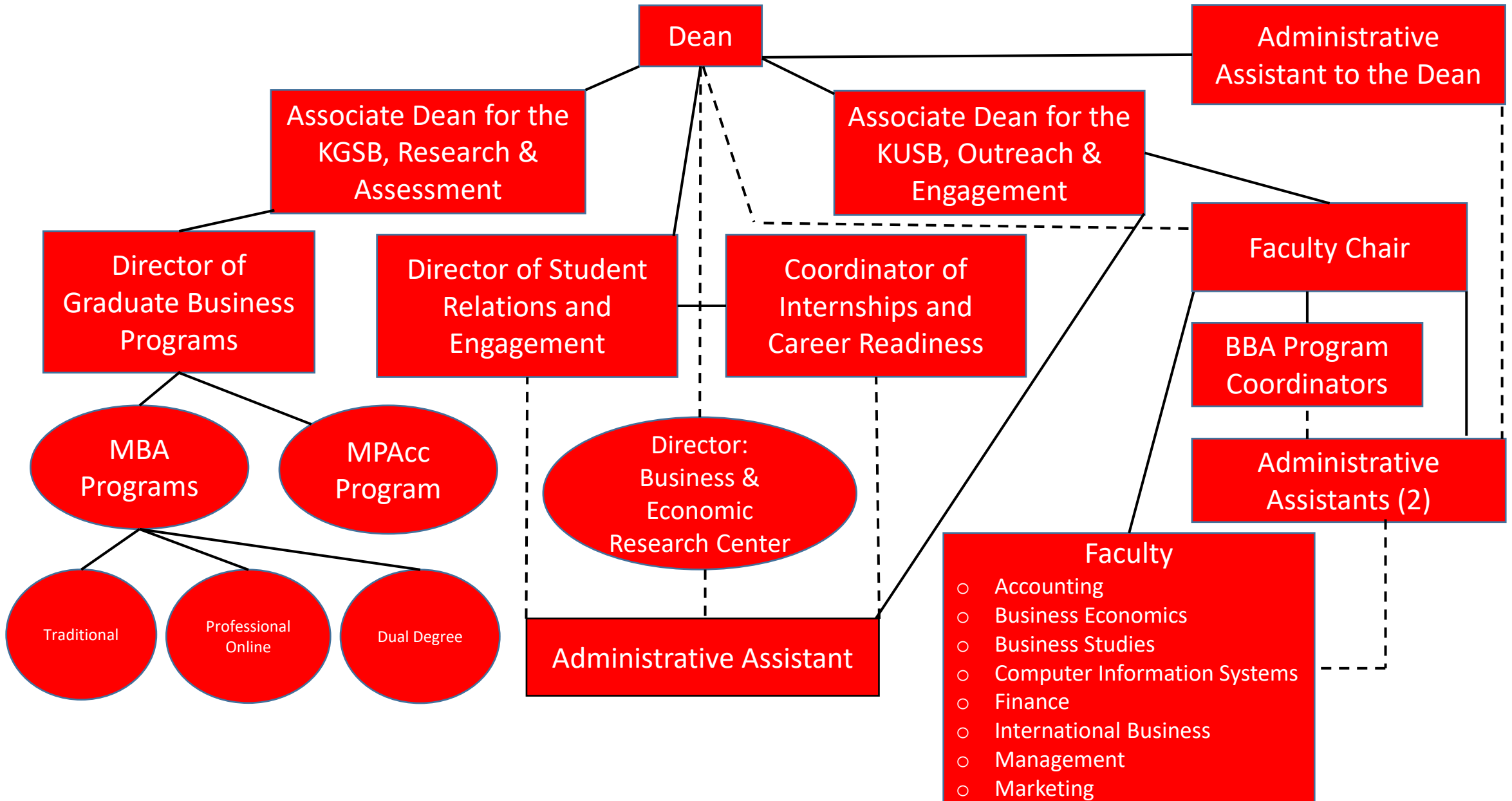

- Achieve at least a 2.25 overall cumulative grade point average for Economics, Finance, International Business, Management, Marketing, and Business Studies majors
- Achieve at least a 2.50 overall cumulative grade point average for Accounting and CIS majors
- Complete any of the following courses you are enrolled in this semester with a grade no lower than a C:
 - English Composition, ENGL 101 or Honors English Composition, ENGL 140- 3 hours
 - Introduction to Research Writing, ENGL 299 or Honors English Composition, ENGL 140- 3 hours
 - Speech Communication, COMM 207-3 hours
 - Elementary Statistics, MATH 143- 3 hours
 - Computer Information Systems, CIS 130- 3 hours
 - College Algebra, MATH 110, 113 or higher-level Math- 3 hours
 - Financial Accounting, ACCTG 201- 3 hours

Additionally, you **MUST** visit the Kelce Student Engagement and Support Center, 102 Kelce, and complete the *Kelce College of Business Application for Admission Form* and sign the *Kelce College of Business Student Oath and Code of Ethics*.

I encourage you to complete these requirements as soon as possible, failure to meet these requirements will revoke your Conditional Acceptance and limit your future course enrollment opportunities.

Policy on Conditional Acceptance for the Kelce College of Business:

Introduction: The Kelce College of Business values academic excellence and strives to provide opportunities for students to achieve their full potential. The Conditional Acceptance policy is designed to assist students who can complete the admission requirements at the conclusion of the current semester.

Conditional Acceptance Communication: The Academic Advisement office will send a list of students who are eligible for Conditional Acceptance to the Kelce Student Engagement and Support Center at the beginning of each semester. Generally, second-semester sophomores who are capable of completing the requirements by the end of the semester are considered for Conditional Acceptance.

Student Notification: Students who are eligible for Conditional Acceptance will receive an email from the Kelce Student Engagement and Support Center, notifying them of their candidacy for admittance to the Kelce College of Business. The email will outline the requirements and provide instructions for admission.

Application and Submission: Students will complete the application for admission and sign the Kelce College of Business Student Oath and Code of Ethics. Upon submission of the required documents, students will receive their padfolio.

Admittance Process: Students who fulfill all the requirements at the conclusion of the current semester will receive their Letter of Admittance/Certificate early the following semester.
