- I. Administrative
 - a. COVID-19 Issues
 - i. New Fed stimulus funds may result in as much as \$14.6M to Pitt State – likely that most will be earmarked for specific uses – scholarships highest priority for us
 - ii. Will consider review of occupancy limits as vaccines roll out; will monitor over time
 - iii. Vaccines to be available to student workers; priority to high traffic & close contact situations
 - iv. 2nd dose vaccines for faculty/staff scheduled for April 8th
 - v. Continue monitoring fall modalities; will not make a premature announcement of “normalcy”
 - b. President Scott testified in legislative budget hearings; some of governor’s cut put back into our budget
 - c. Continuity of operations – asking units to identify priorities and ensure safety of record keeping – backups and accessibility of essential information
 - d. Unit administration – Provost will schedule training for chairs and potential chairs; wants to address serious succession issues across campus
 - e. Audit reminders concerning bidding, invoices, and food for human consumption
- II. Non-tenure Earning Faculty – HR is (finally) rolling out the reset of titles for non-tenure earning faculty
 - a. Ranks to recognize professional progression – will start with next contract year
 - i. Assistant Instructional Professor / Associate Instructional Professor / Instructional Professor
 - ii. Minimum of 5 years of meritorious service before advancements
 - iii. No salary adjustments budgeted at this time
- III. Building Renovation Project
 - a. CIS faculty consulted on layout for mediated room; decision to be “pod” layout instead of traditional rows – will provide most flexibility
 - b. Kristina met with student focus group about food options for coffee shop – good feedback
- IV. Scholarships and Awards Recognition Program – April 9th – schedule determined and letters going out
- V. KBOA video meeting date set for April 16th
 - a. Strategic planning proposal
 - b. Business Studies degree proposal
- VI. Updates
