Focus

My research investigates three primary areas: (1) law and corporate social responsibility, including but not limited to such topics as cause-related marketing and social/economic/ political reforms (2) student selection process regarding college choice and (3) technology's effect on employment.

Impact

The majority of my research focuses on law, ethics, and corporate social responsibility, including case examples and also the social/economic/political reforms that occur when these topics come to the forefront. I have impacted not only scholars, but also practitioners and businesses by my publications in three different refereed journals. This gives me breadth of impact because I published in one journal dealing with managerial issues, one dealing with accounting and auditing, and another dealing with economics and business. My specialty is to write about events relating to law, to present those developments in light of various ethical frameworks, then formulate, suggest and explain appropriate

and socially responsible actions to take. In addition, one of my articles addresses the critical educational issue of the student selection process when making a college choice. Evolving current events such as declining college enrollments certainly make this article especially timely and important. Finally, another of my articles deals with the cutting-edge issue of technology and how it affects today's employment arena. This is another example of how my research is pertinent to the rapidly changing workplace of today, affecting not only practitioners and businesses, but also the community and public at large.
