

COURSE DESCRIPTION

IB-330 International Business (3 hours)

Environmental complexities that arise when business activities and institutions transcend international borders, including forms of doing business abroad and cross-cultural aspects of the management of foreign operations. Prerequisites: MKTG 330 Principles of Marketing and MGT 330 Management and Organizational Behavior.

Explores how recent developments and trends within a hypercompetitive, digitally driven social economy present managers with challenging situations. Companies seeking to operate overseas are confronted with varied and dynamic environments in which they must accurately navigate the political, legal, technological, competitive, and cultural factors that shape their strategies and operations. The fate of overseas operations depends greatly on the international manager's cultural skills and sensitivity

This course focuses on the international dimensions of strategy and organization and also provides a framework for formulating strategies in an increasingly complex world economy, and for making those strategies work effectively. Topics include assessing the environment: political, economic, legal, technological factors; managing interdependence: social responsibility, ethics, sustainability; understanding the role of culture communicating across cultures; cross cultural negotiation and decision making... Topics also include the globalization of industries, the continuing role of country factors in competition, organization of multinational enterprises, building global networks, and the changing managerial tasks under conditions of globalization.

General Course Description & Objectives: The focus of the course is to develop understanding of the major economic, political, legal and cultural factors which contribute to the formation of the international business environment.

The course introduces students to the field of international business which broadly refers to the conduct of business across national borders. An international business, on the other hand, refers to any firm that engages in international trade or investment in a country or countries other than its own. Students enrolled in this course can understand the terminology, theories, principles, models, and frameworks to explain WHY and HOW a firm engages in business in a country or countries other than its own. The course takes a managerial approach in providing an overview of the economic, social, environmental, political, technological and cultural dimensions of doing business across borders as well as the local and international actors that may impact the firm's success in its international business operations.

Furthermore, the course provides an overview of the various strategies, structures, and operations of a firm as it faces the global issues and trends associated with the conduct of business beyond its borders. The course builds on the premise that the business world has become increasingly globalized and borderless and understanding this phenomenon from a managerial perspective is an important element in the study of modern business in a global context. Learning Objectives:

On successful completion of this course, students should be able to:

- 1. Explain the basic terms and concepts that are commonly used in the study of international business
- 2. Differentiate a firm with local or domestic business operations from a firm that is engaged in international business
- 3. Evaluate the managerial importance of economic, social, political, legal, ethical and cultural forces, actors and/or institutions in a firm's conduct of business across borders

- 5. Explain and evaluate the major modes of entry into international markets
- 6. Explain the various operational or functional issues of international business operations with respect to marketing, production and logistics, human resource management and accounting
- 7. Design an action plan for a hypothetical business firm on how to enter a foreign market to take advantage of an international business opportunity.

By the satisfactory completion of this course the student will conceptualize and understand:

- 1. Understand Environmental complexities that arise when business activities and institutions transcend international borders,
- 2. Difficulties of doing business abroad
- 3. cross-cultural aspects involved in the management of foreign operations.

It uses a current methodology for teaching by engagement -- flipped classroom approach—that means that assignments given to you the current week must be recited upon in the class for better learning outcomes (learning assimilation).
