 - August 5, USS and UPS Senate Leadership teams met together after discovering our accounts both had zero balances to begin Fiscal Year 2025. It was concluded both groups should inquire more.
 - ii. Sean met with Vice President of Business, Finance and Facilities Doug Ball, and has been assured that funds are available to support our mission, we just must ask for them.
 - iii. We do know that \$25,0000 of the money provided to the EIT has paid for Linked-In Learning.

Paper process for FY24 announced on May 31, 2024. Month of June designated as Perf Eval Month. (7-12-24 completion rate of 62%.) Four line manager information sessions held the 1st week in June. NEW performance evaluation form designed by committee.

Signed contract with DriveStream to update our Oracle HCM module for Performance Management. Have spent 40 hours on the development so far. Had a dry run for the committee on July 2, 2024. Final testing week of August 12, 2024.

New Functional Analyst, Colton Montgomery from IT, taking the lead on Oracle HCM changes to module. EIT presentation on Professional Development Day, August 14, 2024
